## February 25, 2014

Terry Wagner, President, called the meeting to order at 7:00 PM with the following members present; Terry Wagner, John Richards, Rick Nobbe, Jerome Buening, Mayor Gary Herbert, Director Brittani Saunders, Ron May with Aecon Engineering, and Jay Hall representing Best Way and the Advisory Council.

Minutes and claims were sent prior to the District Board meeting with Rick Nobbe making a motion to accept the minutes and claims. John Richards seconded the motion.

Brittani discussed the Annual report, explaining that it is almost done. However, the totals for 2012 were not carried over correctly for beginning of 2013 so all numbers were incorrect for beginning of 2014. She has now been able to correct these amounts and the Gateway reports will be completed by March 1<sup>st</sup>.

Brittani discussed Education and how she has been meeting with educators in Indiana. In the next few weeks she will be shadowing the educators in the classroom so that she can start the education process here in Decatur County.

Rick Nobbe made the motion to approve the Waste Tire Collection and HHW waste collection documents, Gary Herbert seconded the motion.

With no other business to come before the District Board, Gary Herbert moved to adjourn, second by John Richards.
